**SUBJECT: -Extension of General Affiliation up to Secondary Level.**

This is with reference to school application on the subject cited above. In this connection, I am directed to convey the approval of the Board for Extension of General Affiliation as per details given below:-

<b>Sl. No.</b>	<b>The school is directed to ensure that :</b>
1	The total number of sections of Bal Vatika shall be restricted to 3 (1 section each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to X shall be restricted to 10. Further, the increase of sections will be subject to specific approval of the Board based on the school's request according to affiliation bye law and availability of class rooms of greater than 500 sq ft dimension.
2	The school has constructed a ramp at entrance but it is very steep and does not seem to be navigable by a wheelchair-bound student/staff. Therefore, the school is directed to dismantle the same and re construct the ramp/lift to access upper all the floors with the provision laid in RPWD Act and Board's guidelines ( <a href="https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf">https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf</a> ) within 03 months and submit the compliance.
3	No separate CWSN toilets are seen. The school is required to construct the CwSN toilets separately for boys and girls on each floor with sufficient space for easy movement of the wheelchair as well as handrail on both side of toilet seat (fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and board's guidelines within 03 months and submit the compliance.
4	The composite lab has a single work station, probably for chemistry section, while bio and physics equipment are placed on side slabs which are not conducive for conducting experiments. .The lab should have a separate work station for Bio section and lab standard table for physics section. Sitting arrangement for students is not available. Storage should be separate room or covered racks with restricted access instead of cabinets under work stations which constrain movement of students and are unsafe. The school shall upgrade the lab as per sop issued by the board within 3months and submit compliance on SARAS with videography.
5	Math lab is a temporary arrangement, with equipment is displayed on tables covered with table cloth and no proper workstations / seating arrangements. No storage is seen. The school shall upgrade the lab as per sop issued by the board within 3months and submit compliance on SARAS with videography.

6	Plastic chair in computer lab are inappropriate. The school should provide for computer chairs/straight back upholstered chairs for students seating as per SoP issued by the Board within 3 months and submit compliance on SARAS with videography.
7	As reported by IC, no Grievance/complaint redressal committee is available in the school as well as no NTTs.. The school is required to form the said committee and appoint NTTs as per norms and submit compliance on SARAS portal within 3 months.
8	The school has not submitted Building Safety Certificate from concern Govt Department. The validity period in Safe drinking water and Sanitary Condition certificate is not mentioned Hence the school is directed to obtain fresh certificates (suggestive format is available with Circular no 12/2022) and upload the same on SARAS portal within 3 months.
9	The school shall conduct training of its teachers with CoE Pune within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school is required to renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
8. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

**“The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms”.**

If the compliance is not submitted with in the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
